NHR has long been committed to maximizing the quality of services experienced by the people we support by strengthening and empowering Direct Support Professionals. We support formal education through our Direct Care Certificate programs at local colleges as well as our tuition assistance program. We encourage the attainment of credentials as evidenced by our apprentice program and our NADSP credentialing classes. We recognize the need to partner with other agencies to garner increased recognition of DSPs both inside our industry and in the greater society as well. NHR is an active participant in the Mid-Hudson Coalition for the Development of Direct Support Practice (MHC), the NYS Association of Community Residential Agencies (NYSACRA) and the American Network of Community Organizations and Resources (ANCOR). National Direct Support week demonstrated that through the efforts of many, progress is being made towards attaining professional status for DSPs. The progress may be slow but continues to be made on many fronts and NHR is in the thick of it.

Taking advantage of the timing of their annual conference, the Self Advocacy Association of NYS (SANYS) invited NYSACRA and the newly founded DSP Alliance of NYS (DSPANYS) to join them on Saturday, Sept 12th, 2009 as they held a public march on Wolf Road in Albany. Over 150 people, including several from NHR, recognized the quality of life for people receiving services is directly linked to the quality of the DSPs. It was an awesome public display of unity towards a common goal; a quality life for all citizens. Chants like, "I don't know what you've been told, my DSP is good as gold" were accompanied by signs reading, "Quality of Life because of Quality Staff." It was quite moving.

A Note From the Executive Director....

“The Future Ain’t What It Used to Be”

Help us to get to the future.

For the sake of the children and adults with disabilities whom New Horizons serves, I am asking for your immediate advocacy to contact the Governor and State Legislators and explain what the Governor’s proposed funding cuts of 10 % will do.

Yogi Berra, the New York Yankee famous for his baseball career and his unique brand of elocution, is credited with saying: “the future ain’t what it used to be.” We know what he meant. Today, his malapropos feels appropriate. We are living in unsteady times auguring even more unsteadiness, causing many of us to stumble over our uncertainty of the future. I will outline the problem, state the impact to our services, and propose a plan of action for all those who support New Horizons.

The problem

In the middle of October, Governor Paterson outlined a two-year Deficit Reduction Plan (DRP) that is designed to close a \$3 billion gap in the current fiscal year that ends on March 31st of 2010. For the next fiscal year beginning on April 1st, the deficit is expected to rise to at

least \$5 billion.

Agencies such as New Horizons have a solid commitment to and record of services for people with disabilities. Yet, our reliance on public financial support to realize our mission is more tenuous than it has been since public policy shaped community services for persons with developmental disabilities 40-50 years ago. The State of New York is finding it impossible to balance its budget, and the Federal government has already spent beyond its means in order to stimulate a broken national economy. Although some measures may be working, one gets the feeling that there is no reliable script to follow. In some sense, leaders and followers are making up the answers as they go along. This is not business as usual. It ain’t what it used to be.

Governor Paterson is the chief executive officer of our State, and he has the responsibility to balance our budget. One aspect of his DRP is to impose across the board cuts to the various State agencies such as OMRDD—our licensing and funding agency. New York State’s willingness to cut our funding grows almost week by week.

- **0% increase** reflected in the letter of Robert Megna (Director, NYS Division of the Budget) to the State agencies on September 21st.
- **4% Cut** identified by NYSARC's meeting with the Senate Finance Committee staff on October 19th.
- **10% Cut** quoted from OMRDD Commissioner Ritter's meeting with her Provider Council Meeting held on October 22nd.

As of the first week in November, the Governor is proposing an across the board 10% cut to begin immediately. He warns that the cuts could be deeper if decisions are delayed by the Legislature.

The Impact

The suggested reductions in the Governor's deficit reduction plan, if enacted, will drive agencies like ours to cut deeply into essential services. Our work with people who have developmental disabilities is labor-intensive. It takes people to assist people. More than three-fourths of our budget is personnel costs. It is inescapable that reductions in our workforce will result in reduction in services.

Some agencies that are smaller than New Horizons may cease operations altogether. If that happens, the State will be required to provide services at a much higher cost than the private sector. An important dollars and cents point of view reveals that, for every 39 cents saved in State dollars, an additional 61 cents is lost in Federal Medicaid match funds. When New York State turns back Federal dollars, they are gone forever. From a fiscal perspective alone, it makes no sense. If the State must cut funding, they should consider funding that is 100 percent State dollars.

The not-for-profit sector remains one of the largest employers of entry-level jobs in the State. New Horizons will need to provide a regular pay check and health insurance for workers who would otherwise have to go on unemployment and public assistance, if these cuts go into effect.

Worst of all, funding cuts of this magnitude to a field that has already experienced cuts to the bone will also jeopardize the health and safety of the most vulnerable citizens in our State. This is a serious quality of care concern.

Plan of Action

Because human services are always a target in lean fiscal times, we must advocate as if the life of our mission depends on it. It does. More than in the recent past, self-advocates, family members and the staff who provide the all-important life services are testifying at public hearings and writing their elected representatives because the proposed cuts to services are getting deeper every month.

Talking points: tell the Governor and your Legislators that cuts of 10 percent for services for people with developmental disabilities will:

- ◆ Devastate the OMRDD service system
- ◆ Compromise the quality of care
- ◆ Shut down critical programs
- ◆ Create job loss
- ◆ Negatively impact local economies even further
- ◆ Results in a loss of matching federal funding to the State

Dunlavey*



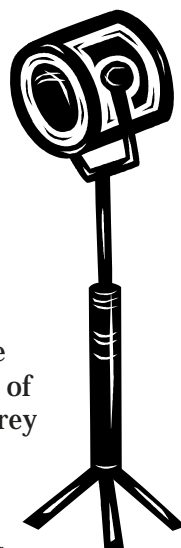
Jeff Dunlavey is a DSP at Albrecht Lane and was selected recently as NHR Employee of The Month. The person who nominated Jeffrey said the following:
